### Ausbil Australian SmallCap Fund (ARSN 630 022 909, APIR AAP5529AU) (Fund)

This Notice to Unitholders updates the Product Disclosure Statement (**PDS**) issued by Ausbil Investment Management Limited (ABN 26 076 316 473 AFSL 229722) (**Responsible Entity**, **Ausbil**, **Ausbil Investment Management**, **we**), as responsible entity of the Fund, and dated 30 September 2023.

In particular, this notice updates the Fund's fees and costs disclosure in the PDS.

Please review this notice alongside the PDS, the Additional Information Guide (**AIG**) and the Target Market Determination (**TMD**), as well as any updates to these documents and information incorporated by reference.
